This session brings together all the different strands of compliance across your organisation into a simple, real time RAG dashboard. With the use of handheld technology we show you how compliance can be more sustainable.

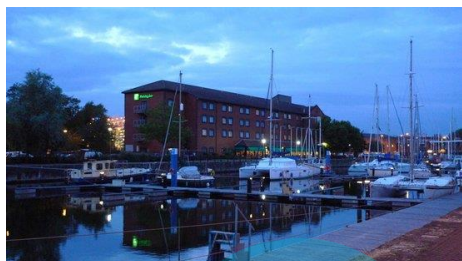

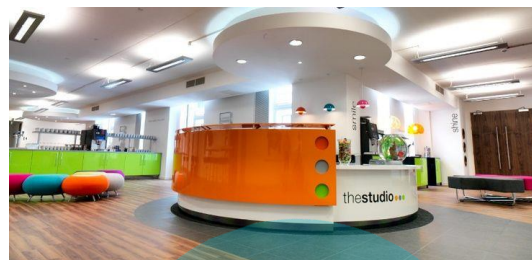
